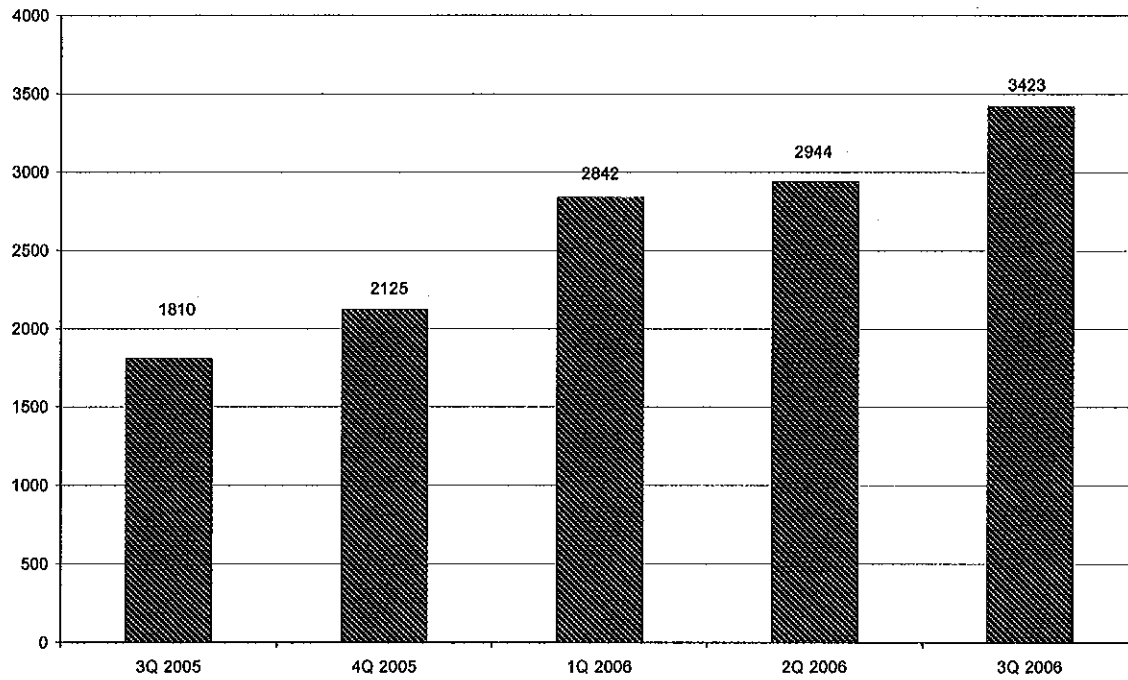
Currently there are 3,421 persons awaiting MI Choice waiver-services. Fifty-four percent of these have been on the wait list three months or less. In the past quarter MI Choice enrolled an additional 785 persons, 118 of which were transitioned from nursing facilities. An additional 825 clients were eliminated from the wait list and of these 76 were placed in nursing facilities. Fifty nursing facility residents are currently on the MI Choice waiting list.

Approximately sixty percent (2,153) of all persons awaiting services are in Detroit metro area. Seventy-two percent of all persons who have waited over seven months are from southeastern Michigan.
