# What is an SPE?

- ...a system that enables consumers to access long term and supportive services through one agency or organization.
- ...the mandatory access point for consumers wishing to access Medicaid-funded long term care supports and services.

### What does it do?

- Provide comprehensive information and referral
- Provide long term support options counseling .
- Conduct functional eligibility determination
- Coordinate financial eligibility determination
- Provide benefits counseling
- Provide LTC crisis intervention/stabilization
- Facilitate person centered planning

# **Core SPE Functions**

Outreach, Education and Advocacy

- Serve as convener of the community around long term care needs.
- Identify gaps in service, advocate for resources to address.
- Establish linkages with major pathways.

# **Core SPE Functions**

Information and Assistance

 Telephone based system to determine needs, evaluate availability of resources, identify organizations that may meet caller needs, locate alternative resources, actively participate in linking caller to needed services, follow up.

# **Core SPE Functions**

Information and Assistance

- Trained and certified I&A coordinators
- Provided at hours convenient for the public
- Toll-free telephone access
- Web-based resource directory
- After hours coverage for emergency and urgent situations.

# Why do we need an SPE?

- Lack of a centralized, neutral source of information and assistance.
- Existing systems, providers and care networks are not well integrated.
- Maze of programs difficult to navigate.
- Costs are skyrocketing.

# How will we pay for it?

- · Reduce duplication, gain efficiency
- Redirect resources from within existing programs, line items
- Realize hetter value through consumer choice of less expensive non-institutional settings


- \$34,83 million for four demonstrations





Western Michigan


- Submitted by HHS and AAA of Western Michigan

# **SPE Demonstrations**

Upper Peninsula

- Submitted by U.P. Commission for Area Progress
- Serves Alger, Baraga, Chippewa, Delta, Dickinson, Gogebic, Houghton, Iron, Keweenaw, Luce, Mackinac, Marquette, Menominee, Ontonagon, and Schoolcraft counties
- Firewall: independent entity within CAP agency.
- Partners include county DHS, nursing facilities, hospital system, 211



# **SPE Demonstrations**

- = 27 month contracts (7/1/06 9/30/08)
- 1<sup>st</sup> quarter start-up activities
  - w Hire staff
  - « Establish governance
  - Establish physical office
  - # Conduct local level planning, outreach
- Target date for initiation of l&A is 10/1/06

# **SPE Demonstrations**

Priority activity is establishing linkages with:

- critical pathways (hospitals, nursing facilities) to divert and transition
- MI Choice waiver programs to document unmet need and advocate for increased program capacity
- DHS home help program to access consumer-directed supports

# **Anticipated Outcomes**

- Slowed growth.
- One primary contact point.
- Coordinated service delivery.
- No (real or perceived) conflict of interest
- Improved quality

# **Planning Grants**

- Planning grants available for regions not funded.
- Will be awarded to independent entities to establish collaborative efforts that bring stakeholders together to overcome barriers and develop proposals.
- Expect in next fiscal year

# ADRC Grant - How does it fit?

- Funding to support consumer participation in governance
- AIRS members, I&A staff certification
- Financial support for resource directory software – licensing, training
- Training in meaningful partnership building and sustaining collaborations
