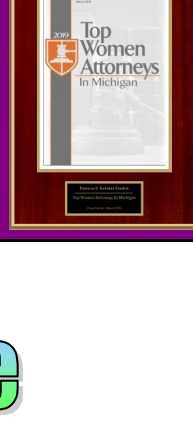

Tax Season is Here

A Tax Break to Help Working Caregivers Pay for Day Care

Paying for day care is one of the biggest expenses faced by working adults with young children, a dependent parent, or a child with a disability, but there is a tax credit available to help working caregivers defray the costs of day care (called "[adult day care](#)") in the case of the elderly).

In order to qualify for the tax credit, you must have a dependent who cannot be left alone and who has lived with you for more than half the year.

Kiddie Tax Changes May Increase Burden for Families with SNTs

Major changes to the "kiddie tax" could significantly increase the tax liability of assets placed in special needs trusts if the trust's beneficiary is a minor and the income the trust earns is high enough.

Up until now, the Internal Revenue Services (IRS) automatically taxed all un-earned income from children above \$2,100 in the same tax bracket applicable to their parents' income. Under the new rules, enacted as part of the Tax Cuts and Jobs Act of 2017, the IRS instead taxes unearned income above this threshold at the greatly compressed tax rates for trusts. Trust income is taxed at a far steeper rate than personal income.

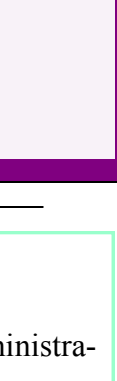

60 Minutes Fails to Consider Pain Patients

[In a Feb. 24 segment](#), CBS's *60 Minutes* accused the Food and Drug Administration (FDA) of igniting the overdose epidemic in the United States with its "illegal approval of opioids for the treatment of chronic pain." While the program highlighted the adverse consequences of misleading pharmaceutical marketing and lax government oversight, this segment failed to consider the perspective of patients who legitimately use opioids for pain, stigmatized them as drug-seekers, and propagated misconceptions about the overdose crisis, such as the idea that opioid treatment for chronic pain is indisputably illegitimate and is driving overdose deaths in the U.S.

Revoking a Power of Attorney

If for any reason, you become unhappy with the person you have appointed to make decisions for you under a durable power of attorney, you may revoke the power of attorney at any time. There are a few steps you should take to ensure the document is properly revoked.

While any new power of attorney should state that old powers of attorney are revoked, you should also put the revocation in writing. The revocation should include your name, a statement that you are of sound mind, and your wish to revoke the power of attorney. You should also specify the date the original power of attorney was executed and the person selected as your agent. Sign the document and send it to your old agent as well as any institutions or agencies that have a copy of the power of attorney. Attach your new power of attorney if you have one.

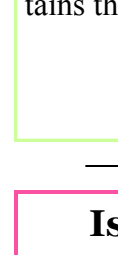
Some Non-English Speakers Would Lose Disability Benefits Under SSA Proposal

The Social Security Administration (SSA) is proposing to make it more difficult for people who don't speak English to qualify for disability benefits.

Under planned regulations released February 01, 2019, the SSA would no longer consider a person's "inability to communicate in English" when reviewing applications, both for [Social Security Disability Insurance](#) (SSDI) and [Supplemental Security Income](#) (SSI) benefits.

The SSA estimates that the move will cut the disability rolls by more than 10,000 non-English speaking claimants.

Proposed overtime pay threshold still too high for some senior living advocates

The Labor Department's [new proposal](#) to increase the salary threshold for employee overtime pay, announced Thursday, might have been expected, but it's still of concern to some organizations representing senior living operators.

Under a salary level set in 2004, executive, administrative, professional and certain other employees who earn less than \$455 per week (\$23,660 annually) are eligible for overtime pay if they work more than 40 hours in a week. The Labor Department's new proposal would raise the standard salary level to \$679 per week, or \$35,308 per year.

It's the effects an increase ultimately might have on residents that concern the National Center for Assisted Living. Senior Director of Policy Lilly Hummel told McKnight's Senior Living. Because of those effects, she said, assisted living operators should be exempt from the rule. "While we're encouraged that the administration has put forth a more moderate proposal, this rule is still concerning for the assisted living profession. Labor makes up a significant portion of overall operations, and increasing those costs could result in additional costs to the consumer," she said. "Many assisted living communities also offer Medicaid to vulnerable residents, which is often underfunded. At a time when residents and their families are looking for more affordable long-term care options, assisted living — especially Medicaid providers — should be exempt from the overtime rule."

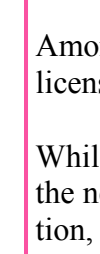
